Dear Mr. Day,

At the regular meeting of Council held on April 7, 2009, Council passed resolution (198-2009 RB2F) to direct staff to submit comments on Bill 150 to the Ministry of Energy and Infrastructure and to the Clerk of the Standing Committee on General Government including the request that the Town of Caledon be involved in the development of the regulations of the Act, particularly as they relate to the new renewable energy project approval process to ensure appropriate municipal consultation.

As part of this resolution, Council also directed staff to submit the following information for your review:

- Planning and Development Report 2009-026 regarding Town of Caledon Comments on Bill 150, Green Energy and Economy Act and resolution 189-2009 RB2F;
- Planning and Development Report 2008-041 regarding Wind Energy Update and resolution W-383-2008; and,
- Council Resolution 172-2009 which supports the Municipality of Grey Highlands resolution regarding the removal of local land use planning controls for renewable energy facilities

During the consideration of the Planning and Development Report 2009-026, Council noted that the definition of "renewable energy project" as contained on page 2 of the Report should include district energy. Further, it was noted by Council that health and safety concerns must be considered for all renewable energy projects.

We trust that the Town's comments will be considered as part of the Province's proposed Green Energy Act consultation process.
