

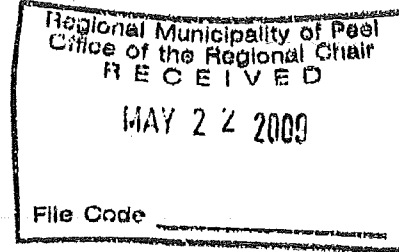

Re: Year 2 Aging at Home Strategy Proposal

Dear Mr. Kolb:

In August 2007, the Minister of Health and Long Term Care announced the Aging at Home Strategy with a provincial investment of \$702 million over three years. For the Mississauga Halton LHIN (MH LHIN) this is a \$33 million investment opportunity for our community, and a real opportunity to advance seniors' health, wellness and quality of life.

As part of the second phase of the Aging at Home funding, the MH LHIN invited the submission of proposals that would address the MH LHIN priorities utilizing Aging at Home objectives. On behalf of the Board, I would like to congratulate Sheridan Villa (Regional Municipality of Peel) on its proposal, *Sheridan Villa Adult Day Service Program: Enhancement of Services and Increased Capacity*.

The MH LHIN will provide an annual allocation of \$165,476 and one time funding of \$10,000 in 2009/2010 for this enhanced service. In a follow-up letter, Mr. Bill MacLeod, CEO, MH LHIN, will provide the administrative details related to this funding including start dates and cash flow for 2009/10.

I would like to take this opportunity to thank you and your team at Sheridan Villa (Regional Municipality of Peel) for your efforts in addressing the increasing need for senior centred services and identifying strategies that will assist in meeting these needs.

We will call on you in the near future to work with the local MPPs and the MH LHIN in the event that we make a formal media announcement of your specific program.
