**Re: Assignment of Service Agreement regarding Vera M. Davis Community Care Centre**

In March 2007, all service agreements between the Ministry of Health and Long-Term Care and Long-Term Care Home (LTCH) operators were assigned to the LHINs. Section 2 of the assignment states:

- 2. The Agreement is terminated pursuant to subsection 19(5) of the Act upon the earlier of:

- (a) March 31, 2009 or such later date as the Ministry specifies:

I am writing to specify the date of March 31, 2010 as the date when the service agreements assigned to your LHIN effective April 1, 2007 and still in effect as of March 31, 2009 will terminate. For greater clarity, the date of March 31, 2010 is being specified by the Ministry for all assigned LTCH agreements that have been transferred to your LHIN effective April 1, 2007 and that are still valid and subsisting as of March 31, 2009.

This new specified date applies to any termination dates for interim and convalescent care beds, but not to any termination dates for beds in abeyance in the assigned LTCH agreements.
