FISCAL 2008**

RECOMMENDATION

That Council receive the attached statement of Development Charge Reserve Funds for Fiscal 2008 as described in Appendix I of the report from the Treasurer and Director of Corporate Finance, dated August 24, 2009, titled "Statement of Development Charge Reserve Funds – Fiscal 2008";

And further, that the Treasurer and Director of Corporate Finance be directed to forward the statement to the Ministry of Municipal Affairs and Housing in accordance with the *Development Charges Act, 1997* and Ontario Regulation 82/98.

REPORT HIGHLIGHTS

- Section 43 of the *Development Charges Act, 1997* requires that the Treasurer of each municipality provide annually a financial statement of development charge related transactions and balances to Council.
- The attached Appendix I – Statement of Development Charge Reserve Funds – Fiscal 2008 summarizes the development charge reserve transactions and activities for the year ended December 31, 2008.

DISCUSSION

1. Background

The attached statements of Development Charges Reserve Funds – Fiscal 2008 have been made available to Council in compliance with the *Development Charges Act, 1997* (DCA). The Act requires that the Treasurer of the municipality shall supply to Council an annual financial statement in respect of each Reserve Fund created under the mandate of the Act.

2. Development Charge Reserve Fund Statement – Fiscal 2008

In accordance with Section 33 of the DCA, a separate reserve fund was established for each development charge service. The monies collected from new development related to By-law 52-2003, By-law 115-2007 and By-law 45-2001 are distributed to the appropriate development charge reserve fund. In 2008, an additional Reserve Fund was established in order to segregate the funds collected specifically for the proposed North South Arterial Road, as jurisdiction of the road has not yet been established.

**STATEMENT OF DEVELOPMENT CHARGE RESERVE FUNDS -
FISCAL 2008**

Section 43 of the DCA requires that the Treasurer of each municipality provide annually to Council a financial statement relating to the development charge reserve funds further described in O.Reg. 82/98 Section 12 and 13, including: opening and closing balances, disclosure of all development charge credits issued that may affect reserve balances, and a list of projects that have been financed from development charge reserves.

Section 14 of the *1989 Development Charges Act* stipulates that current or former owners of land who paid a lot levy are entitled to a credit for those payments. The DCA required owners and former owners to apply for credit by October 31, 1999. The obligation of the Region is for the total credit claims applied for within the prescribed period.

Appendix I, Statement of Development Charge (DC) Reserve Funds for the year ended December 31, 2008, in accordance with the DCA, is structured into the following four sections:

FINANCIAL IMPLICATIONS

As shown below, in the Summary of the Fiscal Status of DC Reserve Funds, existing DC cash balances are fully committed to Council approved projects.




