e. Anita Stellinga, Director, Community Investment, United Way of Peel Region, Presenting the Community Investment Strategy

Anita Stellinga, Director, Community Investment, United Way of Peel Region provided an overview of the Community Investment Strategy. She provided details of the work carried out by United Way, community needs and issues and how the strategy will support residents in the Region of Peel.

The Investment Strategy was developed through a collaborative effort by the Region of Peel and United Way to identify key priorities in the community. The review was carried out through a community consultation process which included focus groups, personal interviews and on-line surveys. Community feedback obtained from the investment review include:

- Endorsing existing funding priorities;
- Determining a different approach in addressing funding community priorities;
- Encouraging more focus on the "building capacity" for individuals, families and neighbourhoods; and
- Encouraging the Region of Peel and United Way to continue to display and support collaboration across the community and other agencies.

In the area of persons with disabilities, some of the outcomes contained in the investment strategy are:

- Reviewing services to increase the quality of life for persons with disabilities;
- Increasing skills of caregivers and family members to appropriately support a person with a disability;
- Increasing access to services and strengthening support networks:
- Increase community awareness and sensitivity to disability issues;
- Increasing the participation of persons with disabilities within the community; and
- Reducing poverty for persons with disabilities.

Anita Stellinga noted that the AAC is a valuable resource and she will be seeking feedback from the Committee on future issues regarding persons with disabilities.

Jan Spry, Committee Member inquired if there are actions within the strategy to ensure persons with disabilities remain independent in the community.

Anita Stellinga responded that the strategy is in the preliminary stage of development and that there may be areas that require improvement. The assistance of the AAC will be very helpful in this respect.

Naz Husain, Vice-Chair of the Region of Peel Accessibility Advisory Committee thanked Anita Stellinga for a very informative presentation and inquired how the Committee can assist in this initiative.

Anita Stellinga responded that she would report back to the AAC to share preliminary findings and obtain feedback.

William Goursky noted the advantages of having community agencies present to the AAC and reiterated the positive outcomes that can be achieved when agencies work in a collaborative manner.

William Goursky advised that members of the Accessibility Planning Program had visited the Peel Heritage Complex as was requested at the September 22, 2009 AAC meeting.

Edward Wong, Manager, Real Property Asset Management and Gillian Haley, Architect, Goldsmith Borgal & Company Ltd., provided an update on revisions made to the Peel Heritage Complex renovation plans, based on AAC feedback including:

- Increased number of barrier-free parking spots;
- Installation of single barrier free main entrances in the courtyard and parking lot;
- Increased number of barrier-free washrooms;
- Elevator access to upper floors;
- Addition of platform lift in staff area; and
- Widening of existing ramp and extension of ramp landing.

Councillor Sandra Hames thanked the presenters for addressing the concerns raised by the AAC.

d. **Meenu Sikand, Accessibility Planning Specialist, Region of Peel,** Providing an Update on the Activities for the 2009 International Day of Persons with Disabilities (IDPD)

Meenu Sikand, Accessibility Planning Specialist provided details regarding the 2009 International Day of Persons with Disabilities (IDPD) event, a full day symposium to be held on December 2, 2009 at the Grand Embassy Convention Centre in Brampton. The objective of the event is to celebrate and share knowledge with the community about accessibility initiatives.

The day will be divided into two segments, with the first half focused on celebrating the accomplishments of persons with disabilities within the Region of Peel and the community. The theme for the celebration will be "Positive Images of Disabilities". Karlene Nation, CTV Diversity Producer has accepted an invitation to act as the Master of Ceremonies for the event. The confirmed keynote speaker is Madeleine Meilleur, Minister of Community and Social Services, who will speak about the *Accessibility for Ontarians with Disabilities Act* (AODA) and the implementation of the accessibility standards. The

Accessibility Recognition Awards will be presented during the morning session.

The second half of the day will include a keynote speaker followed by a roundtable discussion.

Meenu Sikand indicated that each Committee member will be provided with 10 post cards to promote the event. She raised concern regarding the lack of attendance from the hearing impaired community in past years and requested assistance from the Committee to ensure that Sign Language Interpreters are well utilized.

Meenu Sikand stated that TransHelp will be providing free shuttle service to the event. The Committee expressed gratitude to Mark Castro, Acting Supervisor, Administration & Support Services, TransHelp and the TransHelp team for their assistance and combined support.

Councillor Sandra Hames requested clarification on the criteria for nominations for the Accessibility Recognition Awards. Meenu Sikand explained that nominations are open to all Region of Peel employees who have undertaken initiatives to enhance accessibility with the organization.

William Goursky suggested that other municipalities be invited to the symposium. Meenu Sikand noted that invitations will be extended to other municipalities within the GTA.

The Committee recalled IDPD events held in previous years and commended Meenu Sikand for her organizational leadership. The Committee offered its continued support and thanked Meenu for her hard work.
