With the emergence of the pandemic (2009) H1N1 influenza (pH1N1) in the spring of 2009, Ontario's health care system was asked to respond to a new challenge. I am pleased to advise you that the province is providing a one time investment of \$898,301.42 to Peel Public Health in 2010 to reimburse your organization and local health partners for extraordinary expenses incurred during the implementation of flu assessment centres in the fall 2009.
