At the regular meeting of Council held on June 8, 2010, Council received Report PD-2010-036 regarding the Town of Caledon Provincial Policy Conformity Exercise: Adoption of Official Plan Amendment (OPA) 226. The following was adopted:

That Report PD-2010-036, The Town of Caledon Provincial Policy Conformity Exercise: Adoption of Official Plan Amendment 226, be received; and

That Council deems that no further public meetings related to Provincial Policy Conformity Exercise and the resulting Official Plan Amendment 226 are required in accordance to the provisions of Sections 26, and 17 (15) and (16) of the *Planning Act*; and

That Council enact a By-law to adopt Official Plan Amendment 226; and

That all new guidelines, standards, studies and other new requirements that are to be developed in accordance with OPA 226 be brought to Council for approval; and

That the financial impacts of new guidelines, standards, studies and other new requirements to be developed in accordance with OPA 226, on developer, Town and agency resources, must be evaluated prior to seeking Council approval to implement; and

That Council direct staff to submit Official Plan Amendment 226 to the Region of Peel for approval pursuant to Sections 17 and 26 of the *Planning Act*; and

That a copy of this report and Council Resolution along with the final Official Plan Amendment 226 be forwarded to the Ministry of Municipal Affairs and Housing, the Clerks of the Region of Peel and the Cities of Brampton and Mississauga, for their information; and

That Notice of Decision of Council's adoption of Official Plan Amendment 226 be given in accordance with the *Planning Act*.
