Re: Vera M. Davis Community Care Centre Nursing Home License


Thank you for your correspondence of October 6, 2010 regarding resolutions made by the Regional Council of Peel on September 9, 2010 relating to Vera M. Davis Community Care Centre and the Davis Centre.

The Central West LHIN recognizes that the Region of Peel is seeking a single license for 64 long-term care beds by combining the M. Davis Community Care Centre (24 beds) and The Davis Centre (40 beds). Beds for both of the existing homes are adjacent and occupy the same premises.

As I am sure you are aware, responsibility for issuing Long-Term Care licenses lies with the Ministry of Health and Long-Term Care. Once the appropriate licensing has been granted, the Central West LHIN will work with the Region of Peel to establish a service accountability agreement that reflects one combined home.

Subject: Vera M. Davis Community Care Centre Nursing Home Licence

Within the Province of Ontario, there are a number of long-term care homes with more than one designation. The Davis Centre operated by the Region of Peel in Bolton was comprised of 40 nursing home beds and 24 approved beds under the Charitable Institutions Act.

With the introduction of the Long-Term Care Homes Act, 2007 on July 1, 2010, the Ministry of Health and Long-Term Care determined that it would use the majority of beds in each home to determine the designation for all beds.

As a result, I am writing to advise that Regional Council approved the following resolution at its meeting held on Thursday, September 9, 2010:

That the Vera M. Davis Community Care Centre - Davis Centre be licensed as a 64 bed long-term care home under the Long-Term Care Homes Act, 2007;

And further, that the long-term care home license for the Davis Centre be issued to Peel Housing Corporation;

And further, that The Regional Municipality of Peel continue to operate the Davis Centre on behalf of Peel Housing Corporation;

And further, that the Central West Local Health Integration Network and the Ministry of Health and Long-Term Care be directed to refer all reports related to the provision of service, funding and performance improvement to the Region of Peel - Davis Centre.
