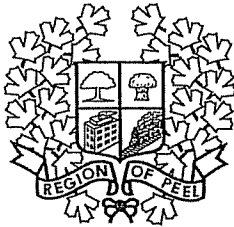

I am writing to advise that Peel Regional Council approved the following resolution at its meeting held on May 10, 2012:
