Thank you for your letter forwarding the resolution passed by Peel Regional Council and the report from the Chief Financial Officer and Commissioner of Corporate Services titled "Further Region of Peel Responses to Provincial Policy Matters."

As you are aware, the Ministry of Municipal Affairs and Housing and various partner ministries involved in land-use planning, including the Ministry of Infrastructure, are currently reviewing the Provincial Policy Statement (PPS) to ensure that it is effective in protecting provincial interests in land-use planning. The recommendations provided in the report, as well as comments provided in previous submissions from the Region, are being given careful consideration as part of the five-year review of the PPS.

I note that the report also provides recommendations related to Proposed Amendment 2 to the Growth Plan for the Greater Golden Horseshoe, which falls under the responsibility of my colleague, the Honourable Glen Murray, Minister of Infrastructure. And further, that a copy of the subject report be forwarded to the Ministry of Infrastructure, the Ministry of Municipal Affairs and Housing, the cities of Mississauga and Brampton, the Town of Caledon, and the Conservation Authorities having jurisdiction in the Region of Peel, for their information."
