Commencing at the most westerly angle of Part 2 on reference plan 43R-9315;

Thence South 44 degrees 34 minutes east (8.230 metres) 27 feet to a point;

Thence North 43 degrees 39 minutes 30 seconds east (30.480 metres) 100 feet to a point;

Thence South 44 degrees 39 minutes 30 seconds east (30.480 metres);

Thence North 44 degrees 34 minutes west a distance of (8.230 metres) 27 feet to the westerly angle of Part 1 on Reference Plan 43R-9315;

Thence South 43 degrees 39 minutes 30 seconds west a distance of (30.480) 100 feet to an iron bar making the most northerly angle of Part 2 on said plan 43R-9315 being the point of commencement.
