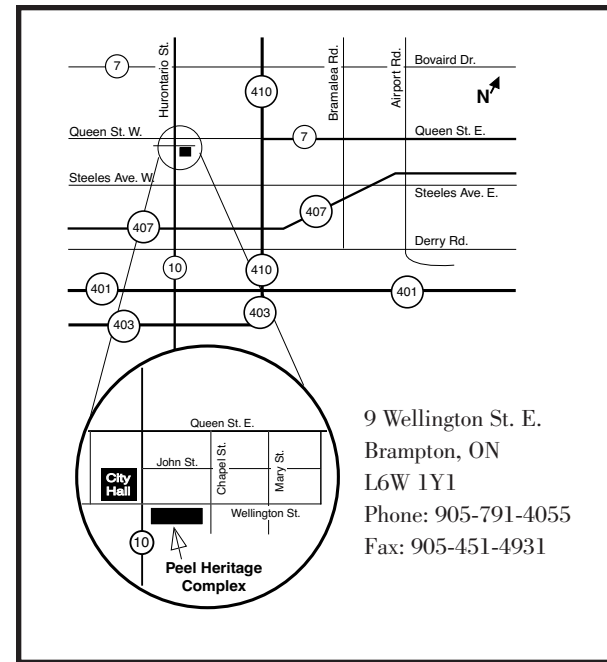

ELIGIBILITY

1. Open to all residents of Ontario.
2. One work may be submitted by each artist and all works must be original and completed within the last 24 months.
3. All mediums will be accepted.
4. All work must be suitably prepared for display.
5. All work must be able to fit through a regular doorframe.
6. Works previously exhibited at the Art Gallery of Peel are not eligible for submission.
7. A non-refundable fee of \$15 must accompany the entry form. A reduced fee of \$12 is available for members of the Peel Heritage Complex. Debit, Visa, MasterCard, cheques and cash will be accepted as payment. Please make cheques payable to the Art Gallery of Peel. Post-dated cheques will not be accepted.
8. Works that do not meet the above criteria will not be presented to the jurors.

ACCEPTED WORK

1. The jurors' decision is final.
2. No entry may be withdrawn from the exhibition once it has been accepted.
3. The artist, by submission of entry, grants the Art Gallery of Peel the right to photograph accepted work for publicity, educational and reference purposes.

TRANSPORTATION AND INSURANCE

1. All delivery and return shipping arrangements and costs before and after selection are the responsibility of the artist. If using Canada Post, please confirm return shipping; staff can not deliver parcels to Canada Post depots. The Art Gallery of Peel will not accept any collect shipments.
2. The Art Gallery of Peel will fully insure all works on its premises from Monday, March 23 to Sunday, May 24, 2009.
3. The Art Gallery of Peel will not insure works in transit.
4. Due to the nature of the exhibition and the large number of works submitted, the Art Gallery of Peel will not be responsible for damage to frames during the selection process and the exhibition.

SUBMISSION DEADLINES

1. Works can be submitted from Monday, March 23 to Sunday, March 29, 2009 during regular Gallery hours. Gallery Hours: Monday to Friday, 10 a.m. to 4 p.m.; Saturday and Sunday, noon to 4 p.m.; Thursday, 6 to 9 p.m.
2. **Selection:** Monday, March 30, 2009.
3. **Notification:** Artists will be notified by phone or e-mail (if provided) of the jurors' decision by Thursday, April 2, 2009.
4. Works not selected must be picked up between Tuesday, March 31 and Sunday, April 5, 2009 during regular Gallery hours. Selected works may be picked up after the exhibition closes from Tuesday, May 19 to Sunday, May 24, 2009.
