## Minutes of Settlement

**Whereas** the Council for the Regional Municipality of Peel, adopted an amendment to its Official Plan, known as Official Plan Amendment No. 24 (ROPA 24), on April 22, 2010, by By-law 34-2010, in accordance with the requirements of the Planning Act, R.S.O. 1990, c. P. 13, as amended (the Planning Act);

**And Whereas** ROPA 24 was subsequently submitted for approval to the Minister of Municipal Affairs and Housing, in accordance with the requirements of the Planning Act;

**And Whereas** each of the Area Municipalities in the Region of Peel, being the City of Mississauga, the City of Brampton and the Town of Caledon, has a direct interest in ROPA 24, as the area official plans will have to conform to the policies of ROPA 24, and each has had staff as active members of the Technical Advisory Committee (TAC) regarding ROPA 24;

**And Whereas** staff of the Ministry of Municipal Affairs issued a draft decision on ROPA 24 on October 27, 2010, identifying a number of proposed modifications to ROPA 24 to reflect provincial interests and to mark a starting point for further collaborative discussions between provincial, regional and local staff, prior to the Minister's Decision on ROPA 24;

**And Whereas** Solmar Development Corporation appealed ROPA 24 to the Ontario Municipal Board pursuant to Section 17(40) of the Planning Act, prior to the completion of those discussions and prior to the Minister issuing a Notice of Decision respecting ROPA 24;

**And Whereas** staff members of the Ministry of Municipal Affairs, the Region of Peel, the City of Mississauga, the City of Brampton and the Town of Caledon, continued settlement discussions and reached agreement, at a staff level, on a set of modifications to the policies of ROPA 24 for recommendation to the Minister, to each of the Councils of the Area Municipalities and to Regional Council;

**And Whereas** these staff recommended modifications to ROPA 24 have now been considered and endorsed by the Minister of Municipal Affairs, the Council of the City of Mississauga, the Council of the City of Brampton, the Council of the Town of Caledon and the Council of the Regional Municipality of Peel;

**And Whereas** the undersigned signatories for each of the parties has been duly authorized to execute these Minutes of Settlement;

**NOW THEREFORE** these Minutes of Settlement confirm the positions and agreement of the undersigned parties, as follows:


1. The undersigned parties agree that the above recitals are true.




