NOTICE OF STUDY COMPLETION New Sanitary Sewer

Fair Birch Drive, Birchview Drive, Queen Victoria Avenue and Lorne Park Road

The Study

The Region of Peel has completed a Municipal Class Environmental Assessment (EA) Study for sanitary sewer improvements on Fair Birch Drive, Birchview Drive, Queen Victoria Avenue and Lorne Park Road. These improvements are required to maintain the system connection to the existing sanitary sewer. The preferred solution is to construct a new sewer within existing road right-of-way to replace the existing sanitary sewer within a branch of Lornewood Creek which will be abandoned.

A Project File Report to document the planning, public consultation and decision-making process for the EA Study will be available for a 30-day review period at the following locations:



Part II Order Requests must be submitted using a standard form available on the Provincial Forms Repository website (www.forms.ssb.gov.on.ca). The form can be found by searching either "Part II Order" or "0122206E" (the form ID number) on the Repository's main page. The completed form for Part II Order Request must be received by the Minister at the addresses provided below by 4:30 p.m. on August 12, 2019 (within 30 days of this notice). A copy of the completed form for Part II Order Request should also be sent the Director, Environmental Approvals Branch and to the Region project team by this time and date at the addresses provided below. If no request is received by August 12, 2019, the Region intends to proceed with detailed design and construction as outlined in the Project File Report subject to receipt of necessary approvals and municipal priorities and budgets.
