
Silverthorn Pumping Station and Reservoir Expansion - Notice of Completion

The Study

The Region of Peel has completed a Municipal Class Environmental Assessment (EA) study for the expansion of the Silverthorn Pumping Station and Reservoir located on Bloor Street in the City of Mississauga. The requirement for expanding pumping and storage capacity was identified in the 2013 update to the Region's Water and Wastewater Master Plan for the Lake Based System. A 2016 assessment of the electrical systems identified the need to replace equipment in the facility.

The Process

Alternative solutions for meeting the approved projected long-term water demands within the serviced area to 2031 and beyond were evaluated as part of the study. The preferred solution recommends expansion of the reservoir and pumping station within the existing site and measures to alleviate any adverse effects that may result from the construction. The proposed expansion includes a larger underground reservoir with a 25 Megalitres (ML) capacity; a building expansion; the construction of an overflow detention area, and an upgrade to a section of storm sewer on Bloor Street. Two electrical transformers and a switchgear unit will also be constructed.

This request (commonly referred to as a Part II Order) must be received within the above review period by the Minister, at the address listed below and copied to Heather Jefferson at the Region of Peel. Provided that no request is received on or before February 26, 2018, the Region may proceed with detailed design and construction of the project as presented in the PFR.
