NOTICE OF STUDY COMPLETION WATERMAIN ON MCVEAN DRIVE (CASTLEMORE ROAD TO COUNTRYSIDE DRIVE)

Study Background and Preferred Solution

The Region of Peel has completed a Municipal Class Environmental Assessment (Class EA) study that addressed the existing and future capacity constraints and security of supply of the watermain on McVean Drive from Castlemore Road to Countryside Drive in Brampton. Expanding the existing watermain from 300 mm to 400 mm meets the preferred water servicing strategy identified in the 2013 Water and Wastewater Master Plan for the Lake Based Systems. The figure shows the preferred watermain alignment (light grey shading) and the existing watermain (dashed line).

In addition, the City of Brampton completed the Class EA for McVean Drive road widening and improvements and is proceeding to detailed design and construction of the project. As it is opportune to implement the water system improvements proposed along McVean Drive ahead of the planned road improvements, the Region is proceeding with a coordinated and combined construction program.

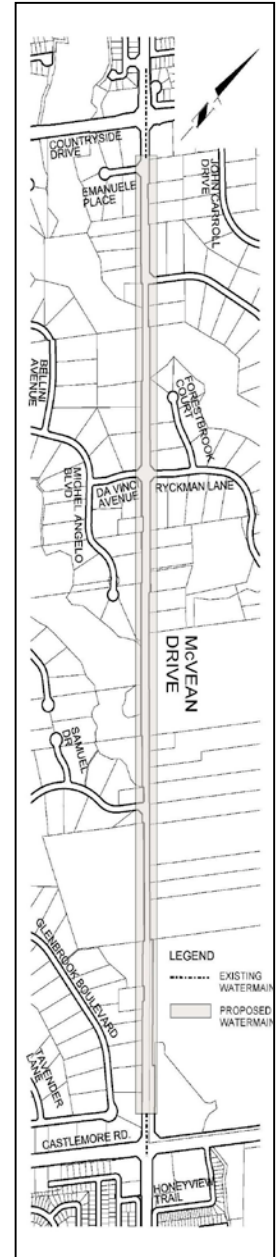
