

## Environmental Assessment Study

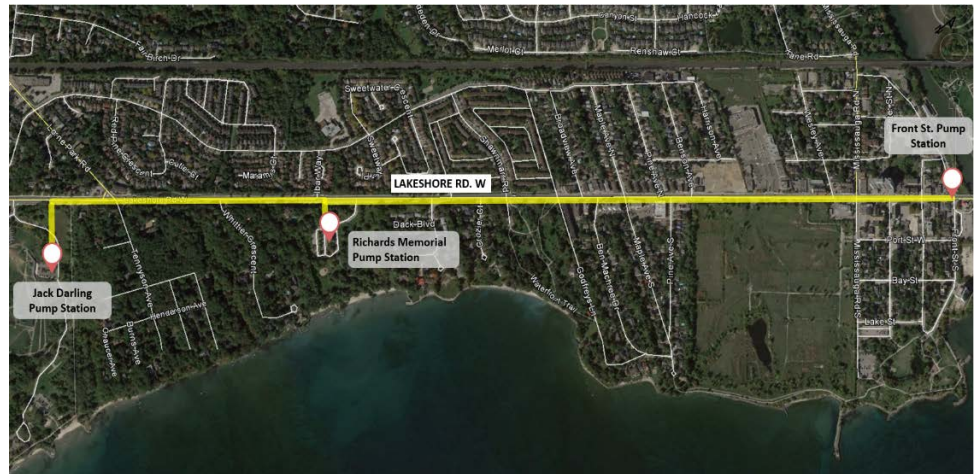
### Notice of Public Information Centre 2 Front Street Station Wastewater Diversion Project

#### Study Background

The Region of Peel has identified the need to address the existing Front Street Station catchment area wastewater flows to align with the Region's long-term sustainable plan to provide wastewater services. As a result, a Schedule 'B' Class Environmental Assessment (EA) has been initiated to identify a solution for this infrastructure need.

#### The Study Process

The study has investigated alternative strategies, routes and design concepts. The preferred solution involves a new sanitary sewer alignment (as shown on the map) and a new pumping station in Richard's Memorial Park.



At the end of the study, and prior to implementation, a Project File documenting the study process will be available for public review for a 30-day period.

#### Public Information Centres (PICs)

As a part of this study, two Public Information Centres (PICs) are being held to present study findings and to provide an opportunity to provide comments and feedback to the project team. The first PIC was held on March 28, 2017.
