RECOMMENDATION

That March 21, 2012 be proclaimed "International Day for the Elimination of Racial Discrimination" in the Regional Municipality of Peel;

And further, that May 1 to 7, 2012 be proclaimed "National Youth Week" in the Regional Municipality of Peel:

And further, that September 2012 be proclaimed "Literacy Month" in the Regional Municipality of Peel:

And further, that October 2012 be proclaimed "Child Abuse Prevention Month" in the Regional Municipality of Peel.

REPORT HIGHLIGHTS

- In 2010, the Region of Peel took a significant step towards promoting a more inclusive community and preventing racism and discrimination by declaring March 21st as International Day for the Elimination of Racial Discrimination.
- National Youth Week is dedicated to the celebration of youth and their active participation in their community and is a time to honour their involvement.
- For over 40 years, the United Nations International Literacy Day has been celebrated in September. Forty-eight per cent of Canadian adults have low literacy skills.
- Peel Children's Aid joins the Children's Aid Societies across the province to build awareness of the issue of Child Abuse in our community through the Child Abuse Prevention Campaign.

DISCUSSION

Through the proclamation of events, the Region of Peel demonstrates its commitment to educating the public and building awareness of the importance of social issues.

The Human Services and Health Services departments take lead roles in celebrating and proclaiming these event days, weeks and months through their commitments to strengthening individual, family and community; investing in community-based services; and providing accessible, high quality and client-centred services.

International Day for the Elimination of Racial Discrimination

In 1966, the United Nations General Assembly honoured the victims of the Sharpeville massacre by designating March 21st as the International Day for the Elimination of Racial Discrimination. A symbolic Regional proclamation in support of this cause and condemning extreme examples of violent racism would be simple. But racism exists in many forms. More than half of Peel's population now belongs to what Census Canada calls a "visible minority." Efforts to address racial discrimination are essential to the future harmony of our community and an essential part of efforts to nurture mutual respect among all the dimension of diversity in our increasingly diverse region.

National Youth Week

National Youth Week is held May 1-7 every year. It is dedicated to the celebration of youth and their active participation in their community. Whether it is recreation, drama, sport, dance, civic engagement, art, volunteerism or leadership, every day young people are involved in meaningful activities during their discretionary time. Young people in their teenage years are an important asset to Canadian communities. The activities, in which youth participate, outside of work or school, teach them to successfully bridge the developmental gap between childhood and adulthood.

Literacy Month

The United Nations International Literacy Day has been celebrated annually in September for over 40 years. The objective of this celebration is to emphasize the importance of literacy and to applaud the efforts made by literacy practitioners and volunteers. Since 2005, Regional Council has approved the Human Services Department's request to proclaim September as Literacy Month in the Region of Peel. The month is used to showcase the wealth of literacy related programs and services offered throughout Peel.

The United Nations Educational, Scientific and Cultural Organization (UNESCO) is coordinating the United Nations Literacy Decade under the slogan "Literacy As Freedom". Launched in 2003 and ending in 2012, the Decade aims to increase literacy levels and empower all people everywhere. As part of this work, UNESCO launched the Literacy Initiative for Empowerment as a framework for achieving the Decade goals focussing on policy driven research, capacity building and advocacy. The "Education for All" objective is to increase literacy rates by 50 per cent by 2015.

Child Abuse Prevention Month

The Peel Children's Aid is a partner in the Peel community in providing leadership on issues that affect vulnerable children and to ensure child protection services are carried out in a responsible manner. Peel Children's Aid also provides care for children and youth who cannot remain in their own homes; however, only after significant efforts to support children in their family home have been attempted. Peel Children's Aid joins Children's Aid Societies across the province in building awareness of the issue of child abuse in Peel through the Child Abuse Prevention Campaign.

INTERNATIONAL DAY FOR THE ELIMINATION OF RACIAL DISCRIMINATION

MARCH 21, 2012

WHEREAS, in 1966, Canada supported the United Nations General Assembly resolution to honour the victims of the Sharpeville massacre by designating March 21 as International Day for the Elimination of Racial Discrimination;

AND WHEREAS, racism destroys the fabric of society, creating barriers to opportunities, prosperity, fairness and democracy, divides communities and erodes the human spirit;

AND WHEREAS, racism combined with factors including but not limited to gender, differing ability, sexual orientation and place of origin compound the discrimination faced by individuals and communities who seek full and equitable participation in the region's political, social, economic and cultural life;

AND WHEREAS, it is everyone's duty to work towards the elimination of racism and discrimination to achieve a civil society where we all have the right to live in conditions of dignity, respect and peace;

THEREFORE BE IT RESOLVED, that March 21, 2012, be proclaimed "INTERNATIONAL DAY FOR THE ELIMINATION OF RACIAL DISCRIMINATION" in the Regional Municipality of Peel.

NATIONAL YOUTH WEEK

MAY 1 TO 7, 2012

WHEREAS, National Youth Week is dedicated to the celebration of youth and their active participation in their community;

AND WHEREAS, every day young people are involved in meaningful activities whether it is recreation, drama, sport, dance, civic engagement, art, volunteerism or leadership;

AND WHEREAS, youth, in their teenage years, are an important asset to Canadian communities;

AND WHEREAS, through activities, such as recreation and art, youth learn five basic life skills, which include social, moral, ethical, physical and cognition competence;

AND WHEREAS, through their involvement, young people are meeting the seven developmental needs such as self-definition, physical activity, meaningful participation, mastery and achievement, positive interaction with adults and peers, structure and clear limits, and creative expression;

AND WHEREAS, in 2006 a resolution was created by a network of Intentional Youth Development Workers from across the country and presented to the Canadian Parks and Recreation Association (CPRA), an organization representing more than 2,600 members across the country and passed unanimously;

THEREFORE BE IT RESOLVED that May 1 to 7, 2012, be proclaimed "NATIONAL YOUTH WEEK" in the Regional Municipality of Peel.
