FCM Elections 2012

Each year, FCM members attending our Annual General Meeting in June elect their representatives to FCM's Board of Directors. This year's Annual General Meeting will be held Sunday, June 3 in Saskatoon, SK, as part of our 75th Annual Conference and Trade Show. Our Board elections will take place in three distinct stages:

1. During the Annual General Meeting, the election is held for the President, the First Vice-President, the Second Vice-President and the Third Vice-President.
2. During provincial and territorial meetings, the election is held for the 70 directors who will represent their province or territory on the Board.
3. During the regional caucus meetings of the five regions (British Columbia, Prairies and Territories, Ontario, Quebec and Atlantic), members select the individual who will represent their region on FCM's Executive Committee.

To run as a member of the FCM Board of Directors - and to be registered in advance, on the electoral list for your province or territory - you must:

- Be an elected official of an FCM member municipality.
- Fill in the **Consent Form** and send it to FCM as indicated.
- Include an official resolution - endorsed by your member municipality - allowing you to seek a position as a member of FCM's Board of Directors.
- Send the Consent Form and resolution to FCM by Sunday, **May 13, 2012**. The instructions for sending these are contained in the Consent Form.
- Attend the Annual General Meeting in Saskatoon.
