We, the residents of Turney Drive in Mississauga, hereby petition the Region of Peel to remove and replace acoustic barriers (wood and brick fences/walls) on the perimeter of our properties backing onto Erin Mills Parkway spanning from the NE corner of Thomas St., north to Hargood Place. This includes the brick walls on the NE & SE corners of Vista Blvd and Erin Mills Parkway.

These fences and walls were erected over 25 years ago by the subdivision's developer and are now environmentally beaten and structurally inadequate to the point where they are collapsing, crumbling and no longer able to provide the required amount of noise control.

Erin Mills Parkway has increased from a two lane road to a major six lane highway. We have been told that the required acoustic barriers must be specifically engineered in order to meet certain regulations and bylaws. This has made replacing them completely unaffordable to us homeowners.

The Region is dictating the type of structure that must be in place and this leads us to conclude that these are Regional barriers and as such need to be replaced as part of an infrastructure project.

The original purchasers and current property owners have never had a say in the erecting of these structures around the City or Region so why now is the Region burdening the homeowner with the

replacement cost. The region's offer to share the cost 50/50 is still unaffordable to us homeowners. Estimates have been obtained and the cost will be no less than \$10,000/ per property.

We are aware that the City of Mississauga has replaced several acoustic barriers in Mississauga after realizing that such costs cannot be borne by the homeowner. As good citizens of the Region of Peel we are requesting that the Region do the right thing and replace all walls and fences backing onto this regional road, thus following the precedent set by the City of Mississauga.

This infrastructure project is urgently needed to address safety, environmental and esthetical concerns in the area.

The attached list contains over 70 names of area homeowners who are being negatively impacted by Region's lack of responsibility for this issue.

We trust this will be reviewed and approval immediately given to replace all fences and walls in this area so as to avoid any further action by us.
