We congratulate Peel for initiating this and look forward to continuing our work with you in the future.

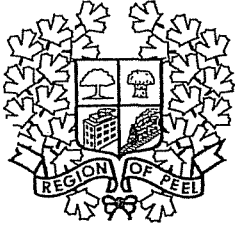
