

## Food Premises Convictions

The Region of Peel - Public Health inspects food premises for compliance with various legislation including the Health Protection and Promotion Act 1990 and the Food Premises Regulation. If a person fails to comply with the applicable legislation, a charge can be laid by a public health inspector.

Below is a list of businesses where a food safety related offence occurred and the owner or operator was charged and convicted. Convictions will be posted for two years from the date of conviction.

This list was last updated on **March 9, 2020** and includes convictions on offences that occurred on or after April 1, 2018.
