

Personal Service Settings Convictions

The Region of Peel - Public Health inspects personal service settings (e.g., businesses that provide services such as hairdressing, manicures, tattooing and ear or body piercing) for compliance with various laws including the Region of Peel Personal Service Settings By-law, Health Protection and Promotion Act 1990, and the Skin Cancer Prevention Act 2013.

Below is a list of personal service settings where an offence occurred and the owner or operator was charged and convicted. Convictions will be posted for two years from the conviction date. This list was last updated on **March 9, 2020** and includes convictions on offences that occurred on or after April 1, 2018.
