

Tobacco and Related Products Convictions

The Region of Peel - Public Health inspects businesses for compliance with various tobacco control related laws including the Smoke-Free Ontario Act. If a person fails to comply with the legislation a charge can be laid by a public health inspector.

Below is a list of premises where an offence occurred under the legislation and the owner or operator was charged and convicted. Convictions will be posted for five years from the conviction date. This list was last updated on **March 9, 2020** and includes convictions on offences that occurred on or after April 1, 2018.
