

Peel Waterpipe Smoking By-Law # 30-2016 Convictions

The Region of Peel - Public Health inspects businesses for compliance with Peel Waterpipe Smoking By-Law # 30-2016. If a person fails to comply with the legislation a charge can be laid by a public health inspector.

Below is a list of premises where an offence occurred under the legislation and the owner or operator was charged and convicted. Convictions will be posted for two years from the conviction date. This list was last updated on **March 9, 2020** and includes convictions on offences that occurred on or after April 1, 2018.
