#### Introduction

**Reaching Home: Canada's Homelessness Strategy** is a federal program that provides funding directly to communities to help them address local homelessness priorities using a more systems-based and data-driven approach. This approach was adopted in recognition that preventing and reducing homelessness requires not only access to safe and adequate housing, but also a high degree of coordination across funders and community organizations, as well as meaningful collaboration between Indigenous and non-Indigenous partners.

The **Community Homelessness Report Summary** is designed to support decision-making using community data. The Region of Peel will use the data outlined in this report to support action plans to reduce homelessness.

#### Describe the efforts that were taken to collaborate and specific plans to ensure it occurs during next year's CHR process.

Collaboration was sought from agencies receiving Reaching Home funding to complete section 1.1 and collaboration was sought from the CAB to review and provide input for the CHR. We have met with a local Indigenous person several times, with intent to build a relationship that will allow connection to our CAB and collaboration on the CHR. We have reached out to several other Indigenous communities and organizations and tried to connect with the Metis of Mississauga but unfortunately no response.

In addition, we have met with Indigenous professors at Ryerson University, University of Toronto to obtain information and increase knowledge. We will continue with our efforts to ensure it occurs, continue to reach out to build relationships but most importantly, the Region of Peel is open to any introductions or support that can be provided by Canada to ensure that collaboration with Indigenous organizations can occur for the CHR process.

#### **Region of Peel**

The 2021/2022 fiscal year saw the Region of Peel and its community partners continuing to work together toward implementation of a local Coordinated Access system. Policies and procedures were established and incorporated into a guide. Participation expectations were defined, and agency roles were solidified. Functions and features specific to Coordinated Access were developed in the Region of Peel's HMIS. Extensive work went into the continued advancement of the legal and privacy framework, with support from the Region of Peel's Housing Privacy Advisor, Senior Legal Counsel and an external lawyer specializing in privacy and technology.

The Region of Peel has faced unique challenges in this area owing to collaboration with healthcare providers who also administer housing supports. The establishment of the necessary policies and agreements is underway, with finalization anticipated for the 2022/2023 fiscal year. Due to the delay in achieving a completed Data Sharing Agreement, Coordinated Access in Peel cannot be administered through the HMIS; an interim process was created to continue to receive referrals and collect information in line with the new intake and prioritization criteria, and manage the By-Name List while awaiting finalization of the data sharing agreement. The Region of Peel has had a By-Name List in place for several years, but was inconsistent in its application of its inactivity policy; in 2022 a clean-up was undertaken to update client records with new information requirements, and continuously purge inactive records. These activities were aimed at improving data quality in anticipation of the onboarding of housing resources expected later in 2022.

#### Are there particular efforts and/or issues that you would like to highlight for this reporting period related to your community's work to transition to an outcomes-based approach under Reaching Home?

The By-Name List was used for the first time to fill an Affordable Housing Opportunity in the Region of Peel, and 10 households from the List were housed during this rent up in November 2021. Significant improvements were made to the referral process, quantity of data collection, and format of the List. These changes were implemented in December 2021. The migration from the old list to this current list required participating agencies to re-refer their clients by answering an additional set of questions. The BNL referral process was expanded to 86 questions, which has enabled a prioritization matrix to be completed based on the additional parameters. This prioritization matrix is to be used for any upcoming affordable housing opportunities that are to be filled using the List. We onboarded one additional partnering agency to be able to make referrals to the List, so we have grown from 5 to 6 participating agencies.

Notably, our community took steps to begin enforcing the 90-day inactivity policy so that the List will be maintained and remain at up to date, real-time, and quality status. Over the next year our plans include increasing partnering agency participation to the BNL (reporting of updates i.e., move ins and closures) and we are aiming to have a total of 12 agencies to be able to make referrals to the List once the Data Sharing Agreement in March 2023. The future state of the List will be to migrate our community's data to our HMIS (Salesforce).





Graph 4-1: People who experienced homelessness for at least one day (that year)













Graph 5-1: People who experienced homelessness for at least one day (that month)










